

## **Company of Heroes 3 Comment Competition Prize Draw**

### **Terms and Conditions**

#### **11. Who are we?**

- The **Company of Heroes 3 Comment Competition Prize Draw** (referred to in these Terms and Conditions as “**the Prize Draw**”) is offered to you by **Gamer Network Limited**, whose principal place of business is at 1-6 Grand Parade, Brighton, East Sussex BN2 9QB and whose registered office is at Gateway House, 28 The Quadrant, Richmond, Surrey TW9 1DN (hereinafter, also known as “**we**” or “**us**”).
- We are the publisher of a number of games industry related websites, including [www.vg247.com](http://www.vg247.com) (“**the Website**”), and we own and control a number of social media sites related to the Website and our other websites.
- The Prize Draw being run by Gamer Network Limited in relation to the Website is for anyone who posts a comment on this competition article (the one to which these Terms and Conditions are linked) or on the associated social media posts referring to the Prize Draw, created by Gamer Network Limited, explaining why they want to play *Company of Heroes 3*, the video game published by the Sega Corporation (“**Sega**”).

#### **12. What terms, conditions and rules apply to the Prize Draw?**

- These Terms and Conditions apply to the Prize Draw.
- You will be deemed to have accepted these Terms and Conditions and to have agreed to be bound by them upon entering the Prize Draw, which you do so by posting your comment about *Company of Heroes 3* within the form indicated in the article, using a specially created Reedpop ID to identify yourself, or on the associated social media posts referring to the Prize Draw, created by Gamer Network Limited.
- If you are in breach of these Terms and Conditions, you may be excluded from access to the Prize Draw.
- You must be over 18 years of age at the date of entry to participate in the Prize Draw and only residents of the United Kingdom can enter.

- Entry into the Prize Draw is via the Website, through the article to which these Terms and Conditions are linked, or on the associated social media posts referring to the Prize Draw, created by Gamer Network Limited.
- Unfortunately, the following persons are excluded from entering the Prize Draw and their entries will not be considered
  - (a) employees of Gamer Network Limited or Reed Exhibitions Limited and any of their associated companies;
  - (b) employees of Sega and any of its associated companies; and
  - (c) any person directly or indirectly involved in the running of the Prize Draw;
- All qualifying entrants who complete and post their comment(s) as outlined above will be entered into the Prize Draw.

### 3. Prize Draw Guidelines

- You must ensure that, upon entering the Prize Draw, your unique Reedpop ID or identifier is provided. If any information supplied is fake or invalid for any other reason, we reserve the right to withdraw the entrant from the Prize Draw. Our decision in this regard is final.
- You will only be entitled to submit one entry for the Prize Draw. Any duplicate entries will be removed by us.
- The Prize Draw will run from midday UK time on Tuesday 13<sup>th</sup> June 2023 and will close at midnight on Tuesday 20<sup>th</sup> June 2023 (“**the Closing Time**”).
- There will be one prize (“**the Prize**”) of one custom-made *Company of Heroes 3* Xbox Series controller, for use on console (Xbox Series X|S), as kindly donated by Sega.
- The winner (“**the Winner**”) shall be chosen at some time after the Closing Time by the Editor in Chief of the Website, whose decision shall be based on what is believed to be the best answer from all the comments submitted by qualifying entrants.
- The Winner shall be notified by the Editor in Chief of the Website via the email address associated with its user's Reedpop ID on or after Wednesday 21<sup>st</sup> June 2023, whereupon the Winner shall provide us with their name and a valid address for delivery of the Prize by either Sega or us.

### Prize Draw Guidelines

- If the Winner fails to provide an email address with the Reedpop ID or if the email address is invalid or if address for delivery of the Prize by Sega or us is invalid, we reserve the right to withdraw the Prize and offer it to another entrant.
- The Winner is not entitled to a cash or other alternative to the Prize.
- The Prize is offered and delivered to the Winner in accordance with and subject to the relevant terms and conditions of use of Sega.
- If you are the Winner, we reserve the right to verify your eligibility and to check or validate your identity. If you have been asked for proof of your identity and/or your eligibility, including your valid email address, age and home address, your failure to provide such proof within a reasonable time could result in your disqualification from the Prize Draw and a fresh Winner being selected. All personal details and information you supply must be truthful and accurate.
- If you are the Winner, we may ask your permission to take your photograph or we may ask you to provide a photograph. Subject to the above, you authorise such photography and permit the use of your photograph, image and likeness for our own or Sega's promotional purposes only.
- We must either publish or make available information that indicates that a valid prize award took place. To comply with this obligation, we will send the surname and county of the Winner of the Prize Draw to anyone who emails us or writes to the address set out in paragraph 1 (enclosing a self-addressed envelope) within one month after the Closing Date. If you object to your surname and county being published or made available, please contact us at the email address at the top of these Terms and Conditions. In such circumstances, you should note that we must still provide Winner's details to the Advertising Standards Authority, on request.
- We may, at our discretion, alter, amend, suspend or withdraw the Prize Draw without prior notice. Any such changes will be indicated on the Website and it is your responsibility to check for any changes.

**4. How much will it cost me to enter the Prize Draw?**

Entry is free of charge. No purchase is necessary and, if you are an eligible applicant, you will be entered into the Prize Draw.

**5. How will we use your personal details?**

We will only use your personal details to operate the Prize Draw, to verify your identity and eligibility and to deliver the Prize to the Winner. The Winner's contact details may be passed on to Sega for the purpose of delivering the Prize.

We will delete all entrants' personal details as soon as the Prize has been delivered to the Winner.

**6. How far are we liable or responsible to you?**

Nothing in these Terms and Conditions removes or limits our liability for fraud or for death or personal injury caused by our negligence or for any liability which cannot be limited or excluded by law. These Terms and Conditions also do not affect the rights that are granted to you as a consumer by law. Otherwise, we will not be liable to you for any matter relating to the Prize Draw. We will also not be liable to you if you suffer loss or inconvenience because of the failures of persons or systems that we do not directly control – for example, mobile phone network operators, internet service providers, postal services, software providers and telephone traffic handlers.

**7. The legal position of these Terms and Conditions**

These Terms and Conditions form a legally binding agreement between you and us. We reserve the right to change them and update them from time to time but, if we do so, we will post the changes on the Website and social media sites, including the Website. The Prize Draw is run and organised by us strictly in accordance with the laws of England and Wales. These Terms and Conditions shall be governed by the laws of England and Wales and the parties hereby submit to the exclusive jurisdiction of the courts of England.
